## GENERAL PROVISIONS

1.	This tariff regulates the interest rates, fees and commissions that DSK Bank AD applies to its business clients, as follows:
1.1.	Sole traders;
1.2.	Legal entities - commercial companies and their divisions, cooperatives and their undertakings, banking and non-banking financial institutions, non-profit associations, etc.
1.3.	Private individuals carrying out economic activity but not registered as traders;
1.4.	Unincorporated associations - non-profit civil partnerships, building co-operatives, mutual benefit societies
1.5.	Budgetary organizations
2.	The interest rates of the Bank are announced in the Interest Rate Bulletin, which is an integral part of this Tariff.
3.	Fees and commissions for transactions in financial instruments, investment funds and registration agent services are separated and announced in a separate document - "Tariff for investment products and services", as of 15.06.2022. All references to the "Tariff on interest rates, fees and commissions, applied by DSK Bank AD for providing services to its clients, when related to the provision of investment services, must be construed and understood as references to the "Tariff on fees and commissions, applied by DSK Bank AD for investment products and services".
4.	The fees and commissions that are subject to Value Added Tax Act are with VAT included.
5.	If charges option is not chosen in the transfer order of a client, such a transfer shall be considered to be ordered with Option "SHA" (shared costs between the payer and the beneficiary). Transfers in foreign currency of an European Economic Area (EEA) country to a payment service provider from an EEA country shall be executed by DSK Bank AD only with option "SHA".
6.	When ordering a transfer in a foreign currency to a non-EEA payment service provider or in a currency other than the currency of an EEA country to an EEA payment service provider, when the sender chooses the option "OUR" (all transfer charges covered by the payer), he shall pay also the respective additional fees for this service, set out in this Tariff.
7.	The Bank reserves the right to collect its receivables from the instructing party of bank guarantees, letters of credit and documentary-collection, when its orders indicate that they are at the expense of the beneficiary/payer and the Bank fails to collect them from the latter.
8.	In cases where a transaction is executed or requires more than one service to be provided, the client shall pay the fees and commissions for each of them on a cumulative basis.
9.	Applicable currency exchange rates (for services, where a currency conversion is needed): <ul style="list-style-type: none"> <li>- For each service, related to cash processing at a teller's desk, as for instance cash withdrawal/ deposit and currency exchange, non-related to a payment service, is applicable the respective exchange rate for cash transaction, announced by the Bank on the day of the transaction, or an agreed one;</li> <li>- For payment services, non-related to cash processing at a teller's desk, is applicable the respective exchange rate for non-cash transactions, announced by the Bank on the day of the transaction, or an agreed one. Exception is made for payment services, provided via debit and credit cards, where exchange rate for card transactions is applicable.</li> </ul>
10.	The commissions and fees indicated in BGN and EUR, in case of need, shall be converted also into another currency, at the BNB respective exchange rate, or in certain occasions at the respective exchange rate for non-cash transactions announced by the Bank, on the day of the transaction.
11.	The fees and commissions regulated in this Tariff shall be collected upon provision a banking service, unless otherwise agreed with the Bank.
11.1.	The monthly fees for maintenance and operational servicing of customer accounts, electronic banking and the packages for business clients are due in the respective full amount, including for the month of termination of the service / closure of the account.
12.	Fees and commissions for used services from accounts used to keep third party funds shall be collected from other payment accounts, where funds of the account holder are kept or shall be paid in cash.
13.	Fees and commissions shall not be collected in the following cases:
13.1.	for servicing the accounts and payments of budgetary organizations, except for:
13.1.1.	- the direct costs incurred by the bank while executing the respective transaction, due by it to the respective payment service provider outside the territory of the country;
13.1.2.	- payments and servicing of accounts, subject to a contract between the Ministry of Finance and the Bank;
13.1.3.	- accounts and transactions of budgetary organizations, where the payment is explicitly provided by law;
13.2.	by non-profit legal entities cited in the State Budget Act for the respective calendar year regarding the following services:
13.2.1.	- opening client accounts in BGN;
13.2.2.	- maintenance and operational servicing of client accounts in BGN
13.3.	from social institutions (for orphans, elderly people, disabled people) on budget support, regarding the following services:
13.3.1.	- opening a client account in BGN;
13.3.2.	- maintenance and operational servicing of a client's account in BGN;
13.3.3.	- intrabank credit transfers in BGN;
13.3.4.	- interbank credit transfers in BGN in the country, except for transfers through RINGS;
13.4.	regarding transactions for raising and spending charity funds and for medical treatment, upon presentation of the relevant documents in a branch of DSK Bank;
13.5.	for payment transactions related to the raising and spending of funds for humanitarian activities of the Bulgarian Red Cross.
